Worcester Pride 2010 (WP10) Guidelines

1. All stall holders and vendors are prohibited from selling alcoholic beverages or bringing glass bottles/containers onto the festival site or its surroundings.
2. All stall holders and vendors are prohibited from selling any memorabilia such as T-shirts, Buttons, posters, banners, balloons, etc., with reference to Worcester Pride on the grounds of Worcester Pride without a written agreement with Worcester Pride for the collaborative sale of said merchandise.
3. All monies must be maintained and stored out of public view at all times. Worcester Pride assumes no responsibility, nor is liable or accountable for any lost and/or stolen monies of any Vendor.
4. It is the responsibility of each stall holders or vendors to secure off-site storage facilities.
5. Worcester Pride shall assign stall holders and vendors spaces.
6. Stall holders and vendors are responsible for cleaning the space allotted to them and transporting their debris to the bin(s) provided.
7. No security shall be provided by Worcester Pride for installations left overnight.
8. Worcester Pride, its successors, assignees and all persons acting under its authority are not responsible for inclement weather and its effects. All fees and transactions are final. NO REFUNDS.
9. All non-profit organisations must show proof of non-profit status to the relevant Worcester Pride Representative.
10. Stall holders and vendors understand that Worcester Pride has no control over weather, acts of God, acts of terrorism, governmental intervention, or any other cause that may prevent, and or interrupt the festival. Stall holders and vendors shall hold Worcester Pride, its assignees, and all persons acting under its authority, harmless for any losses that could arise because of such event.
11. Worcester Pride reserves the right to revise these guidelines without prior written consent and / or Notification. No part of this agreement may be changed in any way or altered without the written, signed permission of Worcester Pride.
